DEADLINES

On or before January 31, 2018: 30% down payment due to secure a booking

June 15, 2018, 2018: Balance Due - payment in full

REFUNDS

Prior to June 15, 2018: We offer a refund of the down payment less \$1,200 per person.

On or after June 15, 2018: We cannot offer a refund as we have committed to all the businesses involved in this tour. There will be no refunds for no shows, late arrivals or early departures from the tour. No refunds in the event of trip interruption; or missed connections, flights or transfers; or in the event of delays or cancellations due to strikes, weather, acts of terrorism, or other events beyond Palmer's control.

INCLUDES

Transfers to and from the airport and all ground transportation by private bus for the entire tour. All hotels are 4/5 stars. Upgraded rooms are available upon request and at an additional cost and are subject to availability. Hotels are located in the most beautiful locations (some centrally located, some a bit more remote). You will visit traditional restaurants where you will sample authentic dishes of the region and meet local food/wine producers.

English speaking guides are at your disposal for walking tours in all the principal places and for each scheduled activity. You will also have your tour guide there for any requests, recommendations or assistance.

All travelers will receive one folder with information about the producers and the destinations that you will visit during the tour. Our intention is to make your trip an unforgettable experience with sightseeing stops, lunches/dinners and visits to food and wine producers.

DOES NOT INCLUDE

Airfare from the U.S. to Greece, gratuities, personal spending money, personal expenses such as laundry or travel insurance, or alcoholic beverages (other than those consumed during tastings or paired wines with meals).

MEALS

It is our goal to provide a unique dining experience which highlights regional specialties. Therefore, we will work with the restaurants to plan a menu for each meal.

CHANGES TO THE ITINERARY

Palmer's reserves the right to make changes to the itinerary, if due to unforeseen circumstances, it becomes necessary. If a change needs to be made, the level of service and quality will be equal to what has been agreed upon in the itinerary.

FORCED CANCELLATION

In the event that we cannot reach the minimum number of tour participants by January 31, 2018 and it is necessary to cancel the tour, you will receive a full refund of all monies received. You will be advised on or before January 31, 2018.

AIR TRANSPORTATION

Air travel from the U.S. to Greece is not included in this trip. Note that all arrivals and departures should be made in the AM.

TRAVEL INSURANCE

Travel insurance is the participant's responsibility and we strongly recommend you take out comprehensive insurance to cover any unforeseen circumstances which may arise. We advise doing this upon making your deposit. For further information, please speak to Cindy Palmer, your own travel agent or use a website to select your plan.

PASSPORTS & VISAS

Participants are required to have a valid passport with at least 3 months validity from the departure date from Greece or the Schengen area. Palmer's is not be liable for any loss or damage resulting from improper passports, visas, green-cards or other documents.

FITNESS
